### Minutes, November 8, 2018 Board Meeting

### **REPORTS & SPEAKERS**

<u>Treasurer's Report</u>: Diane Pellechio reported an ESCA balance of \$26,621.61 and a LPT balance of \$33,717.05 for October 2018. Dick Ulmer passed two invoices, one for attorney fees and one for printing, to Diane. A summary of income and expenses for October 2018 is attached to the minutes.

<u>Membership and HOA report:</u> Diane Pellechio reported that MembershipWorks shows 221 members, but 91 are in arrears.

<u>LPT Report</u>: Dick Ulmer reported that the County has agreed to hold an annual review of the reclamation process around the Vulcan mine. He also reported that Vulcan will have free sand available for luminarias. Diane Pellechio reported that Vulcan is preparing a visual of what the reclamation will look like.

# **OLD BUSINESS**

Office Guidelines: George Franzen reported that the office guidelines are finished except for insurance policy descriptions. Issues concerning our insurance coverage were discussed. Specifically, Dick Ulmer consulted with the ESCA insurance agent regarding protection against "employee dishonesty," which will cover the signatories on our accounts. Currently, our policy only covers \$25K, and since our two accounts exceed that we have agreed to an additional endorsement effective 11/13/18 at an additional \$35 per year in order to provide ESCA with such coverage up to \$75K. -- Open – George

<u>Budget review:</u> George Franzen distributed a draft budget for 2019, based on the current 2018 budget. The 2019 budget will be discussed at the next Board meeting. The draft distributed is attached to the minutes. – open – Board
