# EASTERN SANDOVAL CITIZENS ASSOCIATION BOARD MEETING MINUTES

May 13, 2019 4:30 PM

## Placitas Community Library HWY 165

- 1. Meeting was called to order at 4:30pm
- 2. Roll Call. The following Directors were present: George Franzen (GF), Dick Ulmer (DU), Richard Reif (RR), Jim Harre (JH), John McNerney (JM), Scott Gullett (SG), and Jacques Ramey (JR). The following Director was absent: Wayne Gaede (WG). There is one vacant Director's seat.
- 3. Acceptance of minutes. Minutes were accepted.
- 4. Introduction of Guests. The following guests were present: District 1 Sandoval County Commissioner Kathy Bruch (KB); Kyle Moore (KM), Lell Trogden (LT), ESCA Member Michael Niss (MN), ESCA Member Chris Daul (CD), ESCA Member Mark Brown (MB).
- 5. MONTHLY REPORT ISSUES UPDATES
  - A. Treasurer's Report 2018. Treasurer WG was absent. The report was emailed. On 3-31-29, ESCA had a balance of \$27,389.90. Income included 13 Members paid dues of \$625.00 and accrued interest was \$1.14 for a total income of \$626.14. Expenses included MembershipWorks April monthly fees of \$29.00, CNA insurance for \$521.00, Postage Stamps for \$11.00, and bank fees of \$14.00. The former treasurer's ESCA credit card was closed, ESCA had a credit of \$2.62 which was sent to ESCA in a check from the bank. Total expenses were \$572.82. The ESCA balance as of 4-30-19 is \$27,443.22.On 3-31-19, LPT had a balance of \$31,889.85. Income included accrued interest of \$1.31. There were no expenses. The LPT balance on 4-30-2019 is \$31,891.16. The emailed report is attached.
  - B. Membership Chair & HOA Coalition Report SG. There was discussion about demographics, how to appeal to different age groups. The use of leaflets was discussed, LT proposed that they were almost useless to certain age groups and that social media is much more effective, especially sponsored Facebook pages. SG will explore. The date for the annual meeting and capstone event was decided as 10-19-19. A membership committee consisting of JR, WG, GF, JH, DU, and SG will explore other possible dates, present 3 possibilities to not include Tuesdays or Thursdays. A handout with a plan on the Membership Drive was distributed, attached. -OPEN WG-
  - C. IT Report JH. There were 2 new memberships, 9 renewals, and 2 upgrades from individual to joint since the April meeting. There are 113 total paid memberships, of which 38 are joint memberships. MembershipWorks does have a new a feature to send invoices with direct links to the member account so they don't have to retrieve a

password and then login. However, it is a manual, labor intensive process. We will use it if it becomes automatic. The contact web page had some garbage on it generated by Gravity Forms, for which we did not renew the subscription. I was able to use an embedded form from MembershipWorks for contacts from that page. -OPEN JH-

D. LPT Report– Dick The LPT/County Vulcan mine site visit was held on April 26. Copies of photos were provided from each Sundance site adjoining the Area 3 final mining section to show the before/after view from fence line. We did hear that the yield is decreasing (but still better than the north mine). Vulcan was beginning exploratory drilling in Area 3 (by Sundance) immediately following Buffalo Tract sampling. It was indicated that we need to get an answer regarding what Vulcan intends to do about making the berms to "..be contoured to be aesthetically similar to the area's native topography" as part of the final reclamation.

BLM Status: Bill Diven published (May) first in series of Signpost articles about BLM activity. On April 10, GF, DU & SJ met with the NM Deputy Cabinet Secretary of Energy, Minerals, and Natural Resources, Todd Leahy, to solicit information on how we might best prepare our Governor for her review of the RMP. 4/19/19—DU & SJU did a drive around with staff members of Rep. Haaland. 5/2/19—GF, DU, SJ had a meeting in Santa Fe with NMED Secretary Kinney staff—Sandra Ely, the Division Director, and Ms Bisbee the Air Quality Control head. They will be responsible for issuing permit for BLM mining and expect that a Vulcan request would pass. They suggested we should play "wild horse card" & get nationally recognized environmental group (and lawyer) involved. On 5/8/19—GF & DU met with DOT Cabinet Secretary Michael Sandoval to ask him to support the Governor in stopping the BLM mining. He indicated that DOT should not take issue.

5/9/19 Representative Haaland press release states that she (with Rep Lujan) re-introducing Grisham bill in House. Representative Haaland was also able to get firm statements of support for this bill from the affected tribes.

The first Senate Hearing scheduled for the Senate Bill counterpart (by Heinrich/Udall) beginning 5/14/19.

A letter has been sent to Interior Secretary, David Bernhardt, requesting these lands be withdrawn from any mineral extraction "in aid of pending legislation." This letter and other materials (white paper, resolutions) submitted as testimony to the hearing. Commissioner Bruch also reported that she has been making similar rounds in Santa Fe and has written a letter supporting this bill to the U.S. Senate Committee members holding the hearing.

Exploratory drilling on the BLM land has now been completed—a comment from Vulcan during recent visit was that they still don't know if mining in in the Buffalo Tract would be a profitable venture.

The Sandoval County Commission at 4/25/19 regular meeting passed "Draft Ordinance No. 2-21-19.10, a proposed amendment to the Sandoval County Comprehensive Zoning Ordinance (10-11-18.7A). This included the compromise language negotiated by ESCA to retain recognition of HOA Covenants and the rights of enforcement therein.

#### 6. OLD BUSINESS

- A. Membership Drive Plans from Committee chair. This was covered earlier in the meeting. Look at 5.B. "Membership Chair and HOA Coalition Report.". -OPEN WG-
- B. County Ordinance Amendment Reference Covenants. This was covered earlier in the meeting. Look at 5.D. "LPT Report." -CLOSED-

#### 7. NEW BUSINESS

- A. Need for ESCA Board Members. SG has informed the Board of Directors that he will resign by the end of the year.
- B. DU nominated Peter Adang as a Board member since his eligibility has been established. 2nded by JR. Election was unanimous by the Board.
- C. Software for Recording Secretary. There was discussion about getting Word for Windows for the Recording Secretary, who is using an open source word processor. A suggestion was made to use Google Docs, a freeware word processor available to anyone with a Google account. JM agreed to try it, and these minutes were created on Google Docs..
