- 1. Call to order: Meeting was called to order at 4:01PM

- 5. MONTHLY REPORT
 - A. Treasurer's Report: Wayne Gaede reports an ESCA balance of \$30, 082.25 on September 30, 2020 after income of \$450.24 and expenses of \$530.84. LPT has a balance of \$31,996.60 after income of \$0.26 and no expenses. A breakdown of the ESCA expenses are attached. Wayne Gaede has submitted separately a proposed 2021 budget compared to the 2020 budget to the Directors. There was discussion about modifying the budget for next year, citing differences between this year and next year. Wayne will submit a proposed budget modification.
 - B. IT Report: Jim Harre reported 120 Individual Members and 51 Joint Members for 171 voting members. There were no new members. There were 7 renewals: David Miller, James Wiesner, Maurice Sibaral, Paul Barbeau, Eric Massingcup, Bob Gayle, and Annie Gross.
 - C. LPT Report: Bob Wilkins reports no new reports on Vulcan Mining. George Franzen reports that he spoke to Mary-Rose De Velladares today, she asked him to call Bill Walden. He is a staff member of Senator Udall. George called him at home, he is constrained by his position to engage certain activities. The BLM is in disarray and likely nothing substantive will be done by the US Senate until after the election. In all likelihood, no report will be released until next year under a new Congress.
