Expenses were \$11.67 for bank fees. The balance for LPT as of March 31 was \$32,500.237, which included income of \$0.13 interest.

- c. <u>Land Protection Trust (LPT) Report</u>: LPT representative Mary-Rose de Valladares was unable to attend the meeting, so George Franzen provided the report. We are continuing to press for Representative Melanie Stansbury to file documents with the BLM requesting administrative withdrawal of the Buffalo Tract from gravel mining.

- a. <u>Tony Hull's issues of importance</u>: Regarding working with the Las Placitas Association (LPA) on issues of importance to the community, Tony Hull reported that he attended the most recent LPA meeting. The sole topic discussed was the proposed bike path along Highway 165.
