- A. Call to order. George Franzen called the meeting to order at 4:02 pm.

- b. <u>IT Report</u>: Jim Harre reported that ESCA has 97 members, of which 43 are joint memberships, for a total of 140 votes.
- c. <u>Land Protection Trust (LPT) Report</u>: George and Mary-Rose provided an update on progress to request BLM administrative withdrawal of the Buffalo Tract from gravel mining.

a. <u>Tony Hull on Las Placitas Association (LPA) community issues</u>: Tony Hull reported that he attended another LPA meeting. The main topic was planning for a community hike. He will continue to look into risk assessments of pipelines in Placitas. — CLOSED —
